the agreement signed by the legal representative of the Institute on Air Pollution of the National Research Council, received after the publication of Rector's Decree no CONSIDERED 695/2022, with which the aforementioned body undertakes to co-finance an additional

grant for the PhD in Agricultural Technologies and Biotechnologies;

the D.R. n. 781/2022 relating to the co-financing of an additional scholarship for the PhD CONSIDERED in Agricultural Technologies and Biotechnology DOT1339335 relating to the co-financing

of the additional scholarship referred to in the previous point;

whereas it is necessary to proceed with the appropriate integration of the posts for PhDs CONSIDERED in "Agricultural Technologies and Biotechnology DOT1339335" given the availability of

additional scholarships:

CONSIDERED the need and urgency to proceed promptly to allow the consequential fulfillments;

> art. 18, paragraph 2, letter d) of the Statute according to which the Rector, in case of need and urgency, when it is not possible to proceed with their timely convocation, may

adopt acts of competence of the Academic Senate and the Board of Directors, submitting

them to ratification by the competent body in the immediately following session

## **DECREES**

Single Article - For the reasons mentioned in the introduction, the Public Competition Notice for admission to the PhD courses of the XXXVIII cycle, Academic Year 2022/2023, based at University of Molise, issued by Recto's Decree no. 695 of 22/06/2022, is integrated and amended as follows: Annex A, relating to the PhD in "Agricultural Technologies and Biotechnology DOT1339335", curriculum Food Science, Technology and Biotechnology redefines the number of places with scholarship, increasing the available places by 1 in accordance with what is indicated in the introduction, with the following theme: "The use of emerging biomass in the ecological transition process: characterization and comparison of environmental impacts compared to traditional and renewable energy sources ".
