# Procedures for non-EU students do not apply to:



- citizens of countries in the European Union, as well as from Norway, Iceland, Liechtenstein and the Swiss Confederation, the Republic of San Marino and the Holy See, even if they hold a foreign academic qualification;
- foreign citizens already living legally in Italy as expressly indicated in Art. 39, paragraph 5 of Legislative Decree 2864 of 25 July 1998.

Contact the Italian diplomatic-consular Authority well in advance to find out the requirements for obtaining an entry visa and make an appointment if necessary.



**PRE-ENROLMENT VIA UNIVERSITY  
PORTAL SHALL BE DONE BEFORE  
29 JULY 2022**

Pre-enrolment alone does not grant admission to degree programs. In order to matriculate you also need to accomplish the admission procedures set for the degree program of your interest.

# Requirements for enrollment in a Degree Course

## ***Bachelor or Single cycle degree program***

Candidates must possess a

### **High School Diploma**

acquired after at least 12 years of school.

If this is not the case, the candidate is invited to get in touch with the Institute of their choice to verify applicable conditions

**NB:** When doing the pre-enrolment, candidates need to attach this document to the application, together with a valid passport / ID

# Requirements for enrollment in a Degree Course

## ***Master's degree program***

Candidates must possess a  
**Bachelor Degree diploma**  
or equivalent,

provided that the disciplinary field is compatible with that of the Master's degree of their choice and they possess the requirements of the Master's course regulations

**NB:** When doing the pre-enrolment, candidates need to attach this document to the application, together with a valid passport / ID. Also, a transcript of records or diploma supplement must be attached

# Test of proficiency in Italian



Non-EU students residing abroad who wish to enroll in a degree programme taught in Italian, must prove they possess an adequate level of knowledge of the Italian language for starting university studies.

- Those who wish to enroll in a **restricted access** degree programme, need to meet the Italian requirement before the deadline set in the call.
- For **open access** degree programmes, the Italian language requirement must be met in the available sessions that will take place before the deadline for matriculation.

Those who do not meet the Italian requirement by the final deadline for matriculation, will not be allowed to enroll

# Test of proficiency in Italian - calendar



Tests will be held remotely on Teams in the following dates:

- 29 Aug 2022: for applicants to **restricted access** degree programmes
- 21 Sep 2022: for applicants to **open access** degree programmes

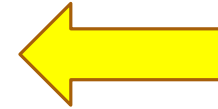

# General requirements for applicants to bachelor degree programmes:

Applicants to **bachelor's degree programmes** must have obtained a secondary school diploma after having completed at least **12 years of schooling**. This diploma must be eligible to access further academic studies in the country where it has been obtained.

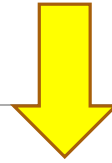

# General requirements for applicants to bachelor degree programmes:

**Applicants who completed 10-11 years of schooling should fill the schooling years gap by...**



- If 11 years: Academic transcripts of records certifying that all the exams foreseen for the first year of university studies have been passed
- If 10 years: Academic transcripts of records certifying that all the exams foreseen for the first and second year of university studies have been passed

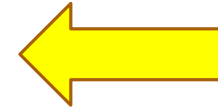

# General requirements for applicants to master's degree programmes:

Applicants to **master's degree programmes** must have obtained a bachelor's degree that is **equivalent to an Italian bachelor's degree** (at least 3 years, 180 ECTS or equivalent).



This diploma must be eligible to access further academic studies in the country where it has been obtained and it must be issued by an accredited institution

# Required documents for accessing Bachelor degree programmes:



- **Final Secondary Education Leaving Qualification** (or provisional certificate, if applicants are currently attending the last year of secondary school or if the final leaving qualification diploma is not ready yet) and its official translation into Italian;
- **Transcript of records** issued by the competent academic authorities, translated into Italian and supported by confirmation of authenticity;
- The **declaration of value\*** of the academic qualification issued by the Italian Embassy in the country where the qualification was awarded;
- Copy of valid passport / ID

\* The **Declaration of Value** (DV) is a document certifying the **value** of a certain academic qualification awarded to a specific person by an institution belonging to an education system other than the Italian one.



# Required documents for accessing Master's degree programmes:

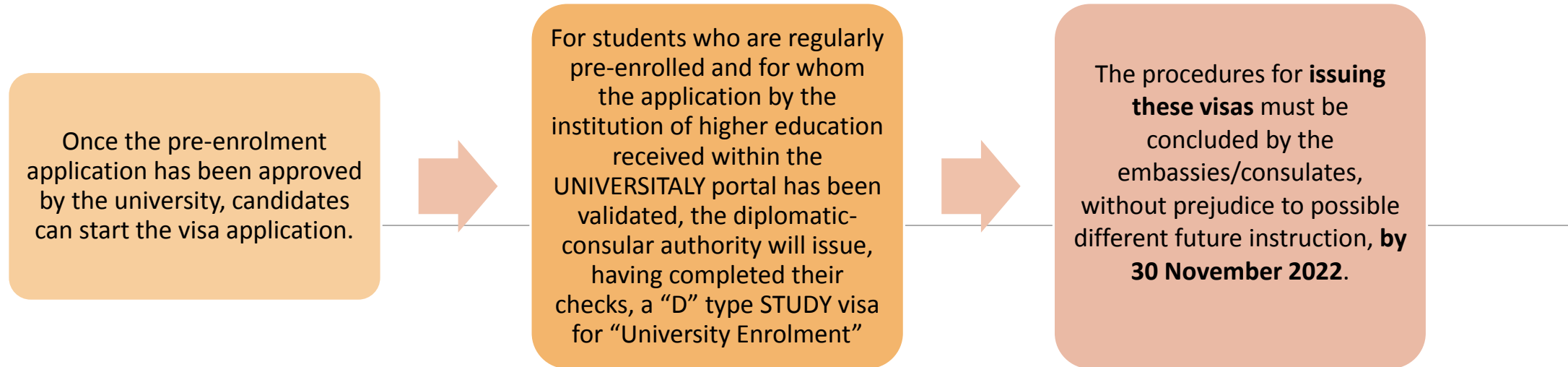


- **A minimum 3-year-undergraduate/bachelor's degree diploma** (or provisional certificate of graduation, if applicants are currently attending the last year of their studies or if the final qualification diploma is not ready yet); and its official translation into Italian;
- **Transcript of records** issued by the competent academic authorities, translated into Italian and supported by confirmation of authenticity;
- The **declaration of value** of the academic qualification issued by the Italian Embassy in the country where the qualification was awarded;
- Official **syllabi** of all the learning activities you completed to obtain the foreign academic qualification, translated into Italian. The syllabi must be accompanied by a declaration of the issuing institution, confirming their authenticity and correspondence with the activities completed by the student. This declaration must be attached to the syllabi. It must be signed, stamped and supported by a confirmation of authenticity
- A **copy of the thesis**, if any, discussed in the final examination held to obtain the academic title, with the relevant translation and legalization.
- Copy of valid passport / ID

# Visa application procedures

**The embassy or consulate is ultimately responsible for the final decision on the issue of a study visa.**

The documentation produced by the higher education institutions in relation to a candidate's application for a visa is considered as supporting information in the evaluation procedures carried out by these agencies, and does not automatically imply the issue of a visa.





## Application for Visa is successful: Requirements upon arrival in Italy

Within eight working days of arrival in Italy on a type D visa for STUDY , the candidates must forward a **request for a residency permit** for STUDY to the police headquarters responsible for the city where they intend to establish their residence.



The request may be presented to Post Offices, using the appropriate kit available at the said Offices. At the moment of presentation, the foreigner will be identified and must effect the payment of the relative costs. At the time of presentation of the dossier at the post office, the student will receive an invitation of summons which specifies the date when he/she must appear at the specific offices of the police headquarters, together with photographs, to undergo the photographic and fingerprinting procedures.



In cases where the dossier must be integrated with further documentation, the student will be informed via text message or registered mail. The Post Office produces a receipt of the delivery of a request for a residency permit

5. **Italian visa for study** (applicants who are still waiting for the issuance of their visa for study will be enrolled under condition, if they possess all other requirements and documents)
6. If available, **diploma supplement** may replace 1)

# Master's Degree Course enrollment procedures for non-EU students

1. **Bachelor's degree final Diploma and transcript of records** (both in the original language and officially translated into Italian) this must be accompanied by official syllabi of all the learning activities you completed to obtain the foreign academic qualification, translated into Italian;
2. **Declaration of Value** issued by the Italian representatives abroad;
3. **Italian Language** Certificate or proof of passing Italian test
4. **Valid ID**
5. **Certificate** declaring that an **academic competence exam** eventually required for entry to University in the Country of origin was passed;
6. **Italian visa for study** (applicants who are still waiting for the issuance of their visa for study will be enrolled under condition, if they possess all other requirements and documents).
