CONSIDERED the announcement, approved by D.R. n. 668 of 08/06/2023, published in the

University Register with Rep. n. 394 of 08/06/2023, with which a public selection was announced for admission to the PhD Courses relating to the XXXIX cycle, with administrative headquarters at this University and the related notice, published in the Official Gazette 4th Special Series - Competitions and Exams, n° 47 of 23 June

2023;

CONSIDERED Annex A to the call for proposals relating to the PhD Courses in Law and Economics

(DOT224STCK) and in Cultural Heritage: memories, civilizations, transitions

(DOT22FT9TS), integral parts of the above call;

DETECTED that in the same annexes the following is reported: "Candidates who have obtained

an overall score of at least 80/100 points will be included in the overall merit

ınking";

LISTEN the Co-ordinators of the respective PhD Courses in Law and Economics

(DOT224STCK) Prof. Francesca di Virgilio and in Cultural Heritage: memories, civilizations, transitions (DOT22FT9TS) Prof. Elisa Novi Chavarria, who transmitted to the PhD Sector respectively with Note Prot. n. 22463/2023 and with Note Prot.

22117/2023 annexes A of the related PhD Courses;

CONSIDERED the manifest illogicality for the minimum threshold set in 80/100 points as all

candidates admitted to the oral with a score lower than 40 would not reach the aforementioned minimum threshold despite achieving a maximum score of 40 points

THOUGHT it is therefore appropriate to revise Annex A to the call for proposals relating to PhD

courses in Law and Economics (DOT224STCK) and in Cultural Heritage: memories,

civilizations, transitions (DOT22FT9TS) in the exercise of self-protection powers

DECREES Single Article

With reference to the call, approved by Ministerial Decree no. 668 of 08/06/2023, and in particular to annexes A relating to the PhD Course in Law and Economics (DOT224STCK) and to the PhD Course in Cultural Heritage: memories, civilizations, transitions (DOT22FT9TS), the clause that provides for the achievement of the minimum threshold of at least 80/100 points for inclusion in the overall merit ranking is annulled, with consequent disapplication, for the technical reasons noted above.
